What is the purpose of this update?

This document tells you how the Asia Pacific Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Asia Pacific Fund invests in the Vanguard FTSE Pacific ETF, which is designed to track the return on the FTSE Developed Asia Pacific All Cap Index.

What are the risks of investing?

Risk indicator for the Asia Pacific Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

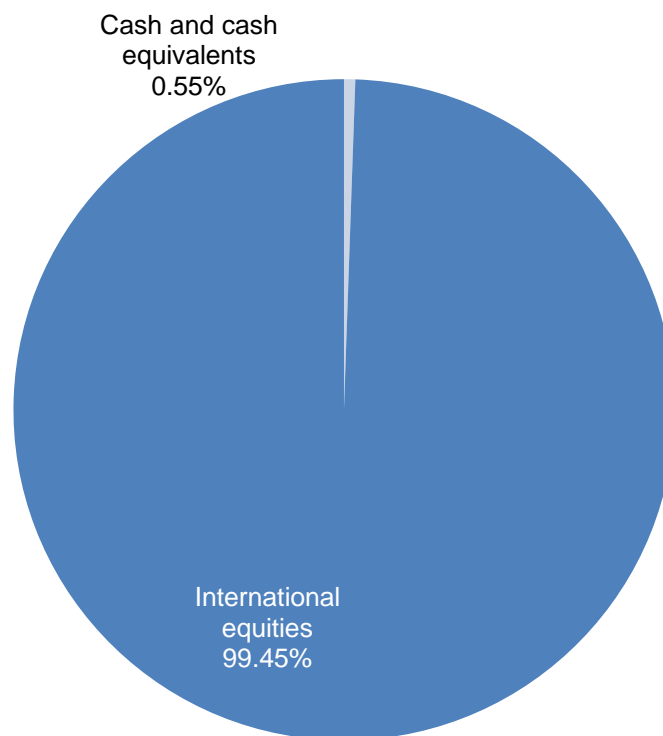
Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted of \$163 (that is 1.63% of her initial \$10,000). Tara paid no other charges. This gives Tara a total return after tax of \$163 for the year.

Notes

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 3 years and 9 months of market index returns.
- 2 To the extent that fund charges involve amounts that are fixed as percentages of the net asset value, those amounts have been used to calculate the fund charges. To the extent that amounts are not fixed, a best estimate of amounts has been used.
- 3 Estimates have been used to calculate this amount. In particular, these charges include an estimate for the fees and costs charged by the other funds the fund may invest in. This estimate is based on the actual fees and costs reported by the other funds for the year ended 30 June 2016.
