What is the purpose of this update?

This document tells you how the Australian Financials Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

The Australian Financials Fund invests in Australasian equities listed on the Australian Securities Exchange and is designed to track the S&P/ASX 200 Financials Ex-A-REIT Index.

What are the risks of investing?

Risk indicator for the Australian Financials Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Small differences in fees and charges can have a big impact on your investment over the long term.

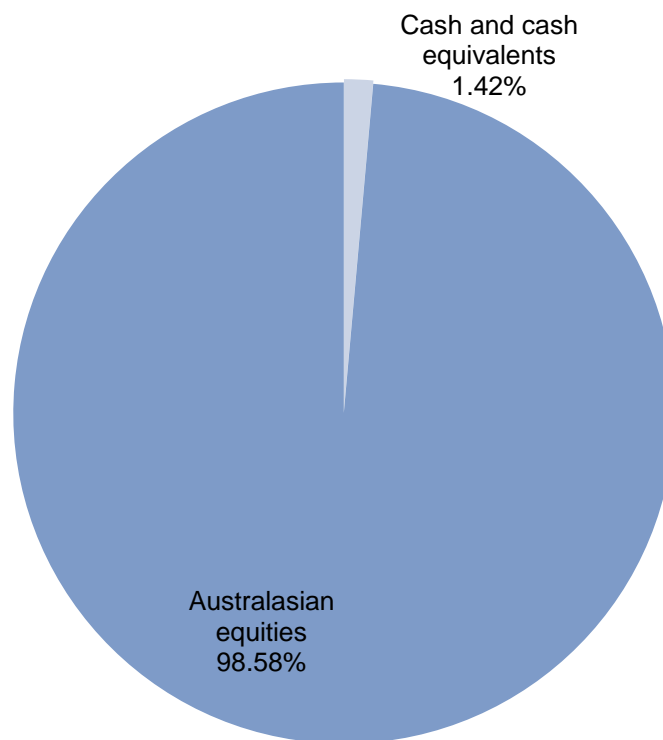
Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara incurred a loss after fund charges were deducted of -\$38 (that is -0.38% of her initial \$10,000). Tara paid no other charges. This gives Tara a total loss after tax of -\$38 for the year.
