What is the purpose of this update?

This document tells you how the Australian Dividend Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

The Australian Dividend Fund invests in financial products listed on the Australian Securities Exchange and is designed to track the return on the S&P/ASX Dividend Opportunities Index.

What are the risks of investing?

Risk indicator for the Australian Dividend Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

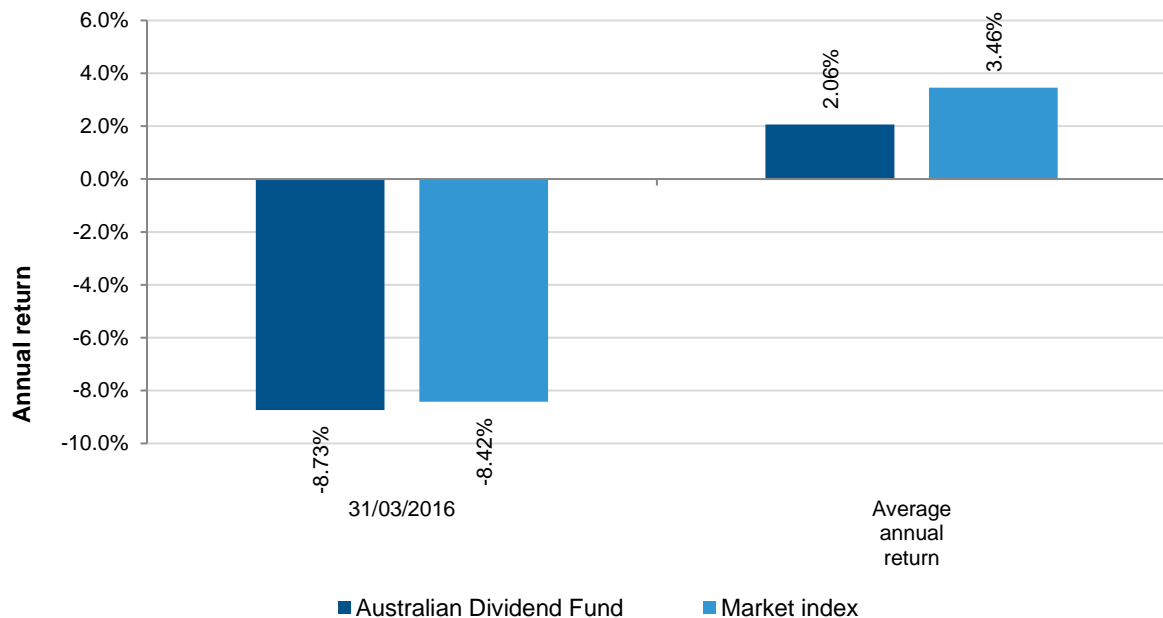

Small differences in fees and charges can have a big impact on your investment over the long term.

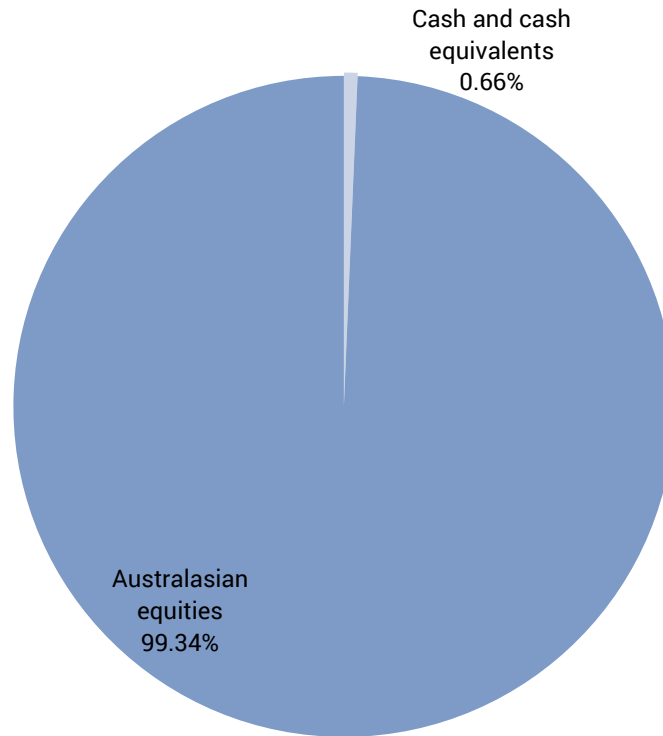
Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted of \$335 (that is 3.35% of her initial \$10,000). Tara paid no other charges. This gives Tara a total return after tax of \$335 for the year.

Notes

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 2 years and 11 months of market index returns.
- 2 The Australian Dividend Fund invests in listed property trusts included in the S&P/ASX Dividend Opportunities Index. This is included in its asset allocation to Australasian equities.
