What is the purpose of this update?

This document tells you how the NZ Mid Cap Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

The NZ Mid Cap Fund invests in financial products listed on the NZX Main Board and is designed to track the return on the S&P/NZX Mid Cap Index.

What are the risks of investing?

Risk indicator for the NZ Mid Cap Fund¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Small differences in fees and charges can have a big impact on your investment over the long term.

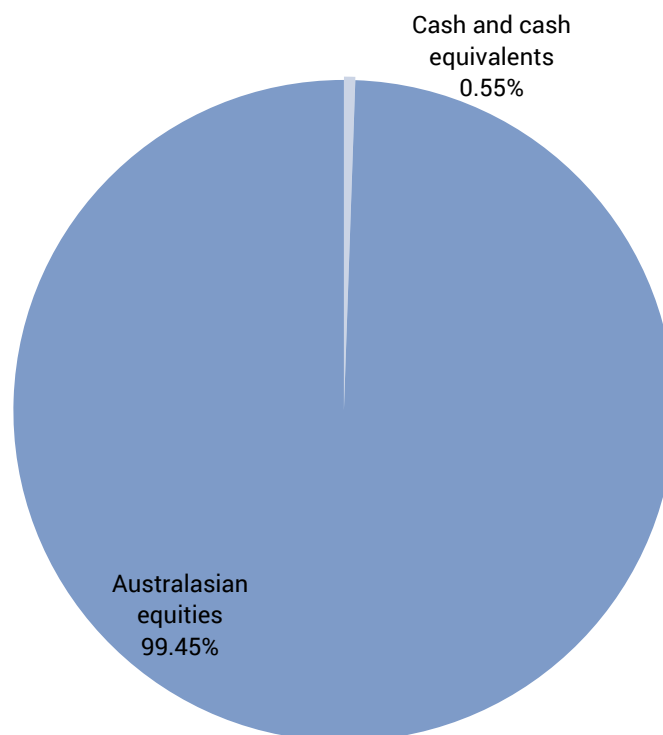
Example of how this applies to an investor

Tara had \$10,000 in the fund on 7 November 2016 and did not make any further contributions. On 31 December 2016, Tara received a return after fund charges were deducted of \$318 (that is 3.18% of her initial \$10,000). Tara paid no other charges. This gives Tara a total return after tax of \$318 for 1 month and 25 days.

Notes
