This fund update was first made publicly available on 13 February 2017.

#### What is the purpose of this update?

This document tells you how the NZ Top 10 Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### Description of this fund

The NZ Top 10 Fund invests in financial products listed on the NZX Main Board and is designed to track the return on the S&P/NZX 10 Index.

#### What are the risks of investing?

##### Risk indicator for the NZ Top 10 Fund<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

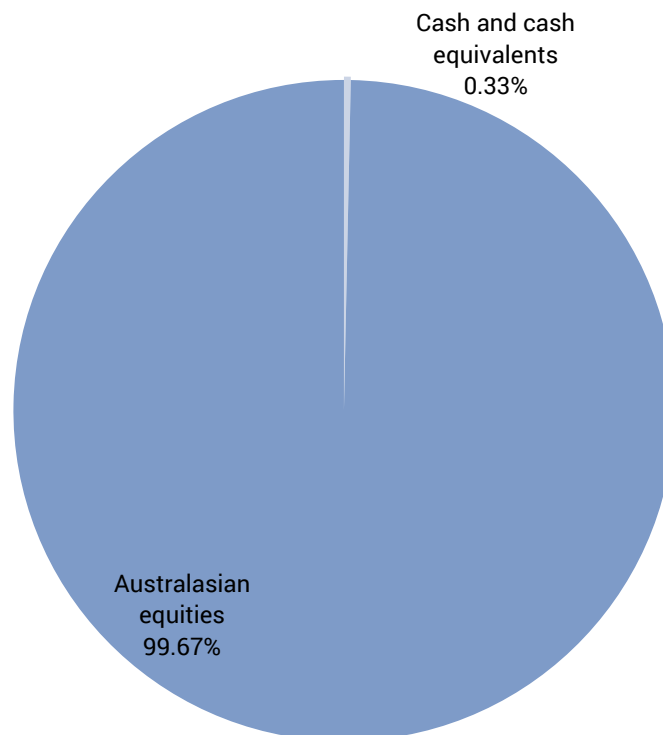
### Example of how this applies to an investor

Tara had \$10,000 in the fund on 7 November 2016 and did not make any further contributions. On 31 December 2016, Tara received a return after fund charges were deducted of \$147 (that is 1.47% of her initial \$10,000). Tara paid no other charges. This gives Tara a total return after tax of \$147 for 1 month and 25 days.
